**RESOLUTION AWARDING A CONTRACT FOR MODERNIZATION OF DETENTION
CONTROL SYSTEM AND DURESS ALARM SYSTEM FOR SALEM COUNTY

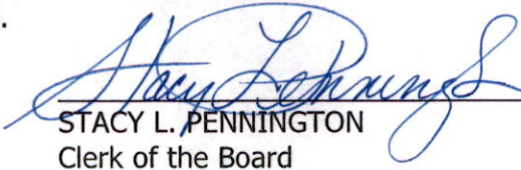

WHEREAS, the Salem County Administration has reviewed the documents and recommend approval to JCT Solutions for this award; and

NOW THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

1. The Salem County Board of County Commissioners hereby awards a contract for Modernization of Detention Control System and Duress Alarm Systems for Salem County Correctional Facility to JCT Solutions, the cost of which shall not exceed \$2,310,196.55 (Two Million, Three Hundred Ten Thousand, One Hundred Ninety-Six Dollars and Fifty-Five Cents).
2. The Commissioner Director and Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.

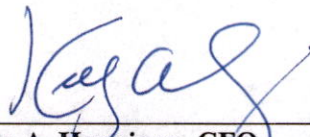
