RESOLUTION AWARDING A CONTRACT PROVIDING AND DELIVERING BULK ROCK SALT & TREATED BULK ROCK SALT FOR THE COUNTY OF SALEM AND MEMBERS OF THE SALEM COUNTY COOPERATIVE CONTRACT PURCHASING SYSTEM IDENTIFIER #SCCP-75, BID #26-15 (RIVERSIDE CONSTRUCTION MATERIALS, INC AND ATLANTIC SALT, INC.)

WHEREAS, the Salem County Purchasing Agent, as authorized contracting Agent for the Salem County Board of Commissioners requested, received and opened sealed bids on August 4, 2026, at 11:00 AM prevailing time for Providing and Delivering Bulk Rock Salt & Treated Bulk Rock Salt for the County of Salem and Members of the Salem County Cooperative Purchasing System, Bid#26-15; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created.

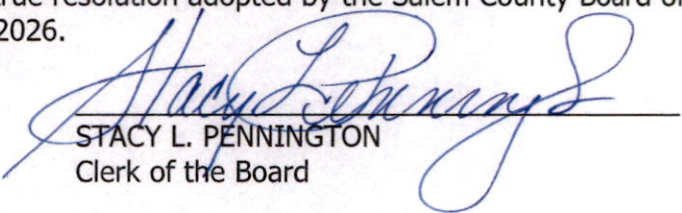
NOW THEREFORE, BE IT RESOLVED by the Salem County Board of County Commissioners as follows:

2. The Salem County Board of County Commissioners hereby awards a contract for Providing Bulk Rock Salt & Bulk Treated Rock Salt for the County of Salem and Members of the Salem County Cooperative Contract Purchasing System Identifier SCCP-75 to Atlantic Salt, Inc.

3. The Commissioner Director and Clerk of the Board shall be authorized to execute said contract upon compliance by the firm with all requirements and specifications.
