## Resolution No. 2026 – 035

### **RESOLUTION AWARDING CONTRACTS FOR CIVIL LITIGATION COUNSEL SERVICES FOR THE COUNTY OF SALEM**

**WHEREAS**, the Salem County Purchasing Department for the Board of County Commissioners of the County of Salem requested, received, and opened sealed proposals on Thursday, December 11, 2025 at 10:00 A.M., prevailing time for **Civil Litigation Counsel** services for the County of Salem, the receipt of which proposal was duly advertised in accordance with the law and in such case made and provided; and

**WHEREAS**, pursuant to New Jersey State Law N.J.S.A. 19:44A-20.4 et. seq. a "Fair and Open" practice, as adopted by the Board of County Commissioners, was utilized by the County of Salem in the determination of this award; and

**WHEREAS**, all proposal results and recommendations for contract award are on file in the office of the Purchasing Agent, 110 Fifth Street, Suite 400, in the County of Salem, New Jersey as required by law; and

**WHEREAS**, the vendors who submitted proposals for Civil Litigation Counsel are as follows:

**WHEREAS**, the below listed are qualified to provide the services of the type and nature to carry out the aforesaid services:

**WHEREAS**, the maximum contract award amount is \$17,500.00 per vendor unless otherwise increased by the Board of County Commissioners; and

**WHEREAS**, no amount will be encumbered until such time as goods or services are ordered; and

**WHEREAS**, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

**WHEREAS**, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$17,500.00 in the aggregate unless otherwise increased by the Board of County Commissioners; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40:11-1 et seq.) requires that the resolution authorize the award of contract for "Professional Services" without competitive bids and the contract itself must be available for public inspection.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of the County of Salem as follows:

1. The Board of County Commissioners of the County of Salem awards contracts for the provision of Civil Litigation Counsel services for the County of Salem, subject to the approval of the County Solicitor, to Aimino & Dennen; Barker, Gelfand, James & Sarvas; Marla Demarcantonio of Holston McDonald, Uzdavinis & Myles; and Marmero Law, Moustakas Nelson, & Rooney Donohue in accordance with the fee schedules on file with the Purchasing Office, in the amount not to exceed \$17,500.00 (Seventeen Thousand, Five Hundred Dollars and Zero Cents) each.
2. The contracts shall commence retroactively, January 1, 2026, and terminate December 31, 2026, and shall be completed in full accordance with the terms and conditions of the contract. Any currently assigned work to these firms shall likewise be authorized to continue.
3. The County Commissioners Director and the Clerk of the Board shall be authorized to execute said contracts.
